THAT I will not belong or get enticed into joining, organizing, participating or attending meeting of any secret society or secret cult activities and will not consume or participate in the consumption of; or lure and encourage any person to consume alcohol, hard drugs, cannabis, cigarettes, tobacco and substance abuse within and outside of Mountain Top University, Prayer City;

THAT I undertake to expose and report any move by any individual or group(s) that make attempt to lure me to join or to participate or to facilitate/encourage any person to join Secret Cult or Secret Society OR to purchase, possess, consume or join in the consumption of alcohol, hard drugs, cannabis, cigarettes, tobacco, or engage in substance abuse; within and outside of Mountain Top University and the Prayer City;
